7.0 PARISHIONER'S TIME

7.1 Mr Olle wanted to express his thanks in finally receiving a sign at the top of The Belt. PA asked for an update on the SK News from Mr Olle and he explained that he is hoping to cease the printing for the SK News from this year and is looking for someone to take over this voluntary role, or if not they will look to outsource. They have received some quotes that will enable them to outsource printing at an acceptable cost. PA discussed the possibility that if SKN does outsource the printing the PC/Village Hall may look at purchasing their photocopier as the current version in the Village Hall is beyond repair..

8.0 TO DISPOSE OF BUSINESS, IF ANY, REMAINING FROM THE LAST MEETING

- Playground Inspection is due to be carried out; SW has contacted HDC to ask for a date and time of the inspection. The insurance company have advised the Parish to speak with the inspector regarding the 'Kick about Wall'.
- 8.2 The Parish have previously signed off grass cuts for the Village Green and opposite. The frequency of grass cutting by LCC has been reduced significantly to five cuts per year, and looking forward this will likely fall upon the Parish to maintain.. **Resolved:** All Councillors were in agreement to allocate the desired verges to be cut by HDC contractor 15 times per year at a cost of £470 per annum as we can absorb the cost of the extra cutting from the existing Precept. PA proposed and RD seconded.
- 8.3 The item above led to a debate around LCC and HDC budget cuts, how these might impact the parish and how the PC should prepare for this. (see 5.1 also). The Parish will have to look at exercising a public consultation with the village when we better understand the impact of the cuts and the options we have to minimise the impact of these on the parish.
- 8.4 Clerks salary increase to be confirmed at the next PC meeting. **Resolved:** ER to look into the inflation percentage and SW will be reimbursed for any increase with effect from the 1st June 2014.
