5.1 Lesley was asked by the Chairman what ramifications will the budget cuts have on effect Parish Councils, and how does she see the responsibilities being pushed to Parishes? Lesley commented that there are not many cuts through the District Council, but are all being made by LCC, a perfect example of this is the recent Bus timetable reductions in service. GB asked what the district are doing to generate income, they are recycling which they received credits for (these are also being cut by LCC), they are looking at merging waste collection and also investing into the Council Offices. All streetlights bulbs will eventually be changed to LED to save costs, these are being slowly rolled out as and when a bulb requires a replacement.

Arriva stated that they have had to reduce the bus service due to the low numbers of the public using it throughout the day, this cannot be subsidised by LCC due to their significant budget cuts. Many of the surrounding Parishes have also expressed their concerns to HDC, but they have only re-iterated what Arriva already stated.
